Monthly Meeting Minutes - September 6, 2022

MEETING ON PROPOSED TAX RATE FOR TAX YEAR 2022 — In compliance with the Tax Code 26.05 and Chapter 551, Texas Government Code, notice is hereby given that the Travis County Emergency Services District No. 13 (ESD#13) will hold a public meeting at 1:00 p.m. on Tuesday, September 6, 2022, at 17808 Lund-Carlson Road (Bethlehem Lutheran Followship Hall), Elgin Texas to consider adopting a proposed tax rate for the tax year 2022. The proposed tax rate is \$0.10 per \$100 of taxable value. The proposed tax rate would increase total taxes in ESD#13 by 3.86%. Notice of the meeting and proposed tax rate was published in the Elgin Courier on August 24, 2022.

- 1. <u>Call to order and establish a quorum</u> Commissioner Erickson called the meeting to order at 1:00 p.m. and established a quorum with Commissioner's Johnson, Anderson, and Douglas attending.

- 3. <u>Discuss/review and act on Proposed Tax Rate for Tax Year 2022</u> Commissioner Douglas made the motion to adopt the 2022 Tax Rate at \$0.10 per \$100 taxable value and was seconded by Commissioner Anderson. The motion passed unanimously.
